

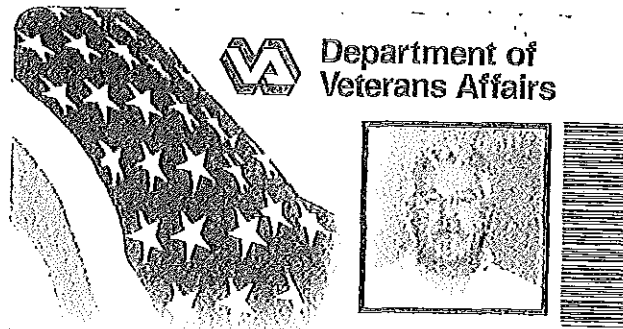

It is not valid for group use, or for supplemental fees such as additional vehicles, horses, dogs, reservations, etc. The pass may be used any day of the week, including holidays, if space is available. The pass and a driver's license (or other suitable form of identification) must be presented at the entrance station. At facilities where fee collection devices are in use, visibly display pass on vehicle dashboard.



This pass is non-transferable, non-refundable, and valid until revoked. Lost or damaged passes are replaceable upon payment of the full purchase price.


